  - Calvert VFD request totaling \$1,209.79
     Commissioner Mathews made a motion to approve Calvert VFD's reserve funding request of \$1,209.79, \$489.79 going to vehicle maintenance and \$720.00 to equipment testing. Commissioner Henry seconded the motion, the motion carried.

Commissioner Henry made a motion to approve Payment of Robertson County Emergency Services District monthly expenses, including payroll, RCEMS, tower expenses, and a funds transfer of \$325,000 from Super Now to Money Market. Commissioner Mathews seconded the motion, the motion carried.

Update was given. Generator installed and propane connected. Temporary meter is in and power is on. Racks are in. Pending: internet equipment install, HVAC to be commissioned, Bremond cabinet is blocked, container door may be leaking, alerting systems need to be set up, and planning meeting to move equipment.

Equipment is needed ahead of time for FY25 truck that must be installed when truck is built. Roughly \$16,698.88 plus S/H.

Commissioner Mathews made a motion to approve Robertson County EMS to purchase equipment for FY2025 ambulance and to adjust budget from reserves for total of \$17,200. Commissioner Sanders seconded the motion, the motion carried.

- 14. Consideration, discussion and any approval of Corrected Resale Deed sold in September of 2014, Lot 10-B, Block G, Rodell Subdivision an addition to the City of Hearne and Resale Deed for Lot 1, Block 95, City of Calvert. (Action Item)

Corrected deed has already been approved, just needs signature. Lot 1 in Calvert was struck off of tax records in 1944 and given to Robertson County. Artis Allen thought they had purchased Lot 1 and 2 at tax sale but only had Lot 2. They are now wanting to purchase Lot 1. County and City of Calvert have approved sale of lot.

Commissioner Henry made a motion to approve signature on corrected resale deed for Lot 10B, Block G, Rodell subdivision City of Hearne and the sale of Lot 1, Block 95, City of Calvert for \$2,500 and approved appropriate signatures. Commissioner Sanders seconded the motion, the motion carried.

Blackjack - fish fry last month had a good turnout, pump issues resolved on main engine but now has phone and AC issues
